Terms and Conditions

Registration

Registrations for the Young Leaders Network Reunion are handled electronically by Lil Regie Ltd. Once registration is received, confirmation will be emailed to you. A permanent record of this is maintained and we can re-issue these items if yours get lost.

Payment

Early bird registration is \$250.00+GST and closes on 30 November 2011. From 1 December 2011, the registration fee is \$300.00+GST. The last day of registration is 31 January 2012 or once we've reached full capacity.

Registration fees can be paid by credit card or invoice. If you request to pay by invoice, you will receive an invoice within 5 working days. Payment must be made within 7 days of receipt of invoice. If payment is not received within 7 days, your registration will be cancelled and you will be required to re-register (if places are still available).

Cancellations and refunds

The registration fee, (less \$50 administration charge), is refundable for cancellation received in writing before 31 December 2011. No refunds will be issued after 1 January 2012, as Asia New Zealand Foundation will incur costs after this date.

Responsibilities

All participants agree to take part in all scheduled activities and events at the reunion.
